- **Provided funding to 34 programs that were accessed by over 63,000 residents of Barry County in four funding areas: Helping youth achieve their full potential, addressing urgent and emerging needs, supporting families to achieve well being and success, and assisting seniors adults find support and maintain independence.**

- **The Barry Copunty United Way was also able to provide direct assistance to clients through housing and utility state grants as well as the Veterans Affairs office for our community.**
